

PICK-A-DILLY MARKET RULES

The following regulations will govern vendors at the Pick-a-dilly Market:

*** CHECK IN AT DESK UPON ARRIVAL IN LOBBY. ***

BOOTH SET-UP: Booth assignment is at the discretion of the show management. You can request a certain space, but it may be altered at the discretion of the event management. ***Assignments will be emailed to you one week prior to the event.*** Indoor booths will receive one chair, but it is your responsibility to bring tables. We do not provide tables. A few spaces will have electric outlets available, but this cannot be guaranteed.

SET-UP TIME: St. Peter's will open for vendors to set-up at 6:30 a.m. on Saturday, October 19, 2024. Early set-up will not be available. All exhibits must be ready to open by 9 a.m.

PARKING: Once you have completed unloading, please move your car to the parking lot of Taylor High School across the street from the church. Please respect this request, as we want to ensure there is parking for customers. Handicapped parking spots are available at the church, but you must have a visible tag or license plate to use a spot. There will be **NO PARKING** in the Shillington/Kingsland corner parking lot where we have outdoor vendors this year.

EXHIBIT HOURS: The Pick-a-dilly Market will be open from 9 a.m. - 4 p.m. on Saturday, October 19, 2024.

SELLER RESTRICTIONS: Vendors are not allowed to sell products that contain CBD or Hemp Oil in them. Vendors are also not allowed to sell or display political content that either supports or denounces any political party or person.

BOOTH TEAR-DOWN: Vendors must take down their items at 4 p.m. and leave by 6 p.m. on Saturday, October 19, 2024. Due to traffic control, safety concerns, and to show courtesy to the other exhibitors and guests, you **cannot close/clear your booth early** (prior to 4 p.m.); additionally, the exhibit area must be cleared by 6 p.m. There are **NO EXCEPTIONS** to this rule.

SECURITY: Vendors are not guaranteed against loss or damage. Do not leave items unattended inside or outside the buildings. St. Peter's is not responsible for loss, damage, or theft.

ALCOHOL CONSUMPTION AND SMOKING: No smoking or consumption of alcoholic beverages will be allowed on St. Peter's property. Please use spill-proof cups for your beverages.

ALL FOOD AND DRINK SALES WILL BE PROVIDED BY VARIOUS ST. PETER'S ORGANIZATIONS. Vendors may bring their own food and drink for personal use or purchase drinks and food being sold in the Food Court off the main Lobby.

CANCELLATION: No refunds will be issued due to inclement weather. We have a no-cancellation policy for vendors, although it may be given for an emergency at the discretion of the event host in a case-by-case situation up to **thirty days** prior to the event **only**.
